Karin von Strokirch asked whether the NERAM Foundation Investment Committee is verifying whether NERAM investments are in ethical funds and/or shareholdings. Andrew Murray responded that the committee does conduct periodic checks of where the bulk of managed funds are being invested but noted that this was challenging given the volunteer nature of the committee and the structure of current investments.

Note that in view of Andrew's response about the committee being run by volunteers Karin did offer to assist in checking the ethical credentials of NERAM's investments but this offer has to date not been taken up. The offer remains open.

Kim Taylor presented the consolidated Financial Report for the period 1 January to 31 December 2022.

Formal thanks to Leah Gilby for her work on the audit.

Financial statements are sound and reflects a return to normal exhibitions, public programs, and commercial activity after two years of disruption due to Covid19. A surplus was achieved but ongoing pressure on costs to be expected due to increases in service costs. Net Assets continue to improve with donations of artworks and valuation changes to the NERAM collection. Some decline in combined investments portfolio in line with the current market.

Outlined the allocation of two reserves: the Helen Dangar Memorial Art Bursary and the Adopt an Artwork program, sub-funds of the Foundation.
