Acknowledged and thanked key funding supporters the Armidale Regional Council and Create NSW and discussed NERAM's close partnership with UNE.

Provided an update on the building project, acknowledging both the challenges and opportunities that the project presents.

#### 5. Finance Reports

Andrew Murray provided a report on the Foundation investment.

Kim Taylor presented the consolidated Financial Report for the period 1 January to 31 December 2023.

Thanked Leah Gilby, Meagan Playford and Forsyths for their work on the audit.

The financial performance for the 12 months to December 2023 were again stable, with another net positive year for NERAM operations.



Achieved a consolidated surplus for the year of \$318,253, from a total revenue of \$1,748,000.

Major standouts was in employee benefits expenses, an increase of approximately \$80,000 on 2022, this includes CPI increase on wages (\$22k), additional provisions for leave (24K), changes in wages allocation for Education and Comms roles(37K) and additional special payments for Workcover and parental leave.

Financial Position has continued to improve. net assets are siting at \$41,681,000, of which \$38,485,000 is Collections.

Combined investment portfolio was valued at \$1,189,255. This represents a 9% increase in the fair value of investments after distributions.
